- Based on feedback from site visitors and programs, the Site Visit Evidence List for CSSRs and PSSRs has been revised (as well as the On-Site Review Checklist on page 2 of SV Reports). Please familiarize yourself with these changes.
- A reminder to wear appropriate business attire during the site visit - you are representing CoARC and the profession.
- Policy Change Regarding Key Personnel Involvement during a Provisional SV:
 - The Program Director must be in attendance and available to the on-site review team throughout the visit. If the start date of the DCE's employment occurs prior to the visit, the DCE must also be in attendance throughout the visit. determined by the site visitors. If either of the Key Personnel is unable to meet the above requirements due to unanticipated circumstances, the on-site visit may be rescheduled at a later date at the discretion of the CoARC Executive Office and the Referee. Should it be determined, in spite of such absence/ unavailability, that the site visit should proceed, the team will complete as much of the evaluation as possible during the visit. Should it be deemed necessary by the Executive Office/Referee, a focused site visit will then be rescheduled at a later date.

The Medical Director/Advisor should also be available for either a face-to-face visit or by conference call. This call may occur either prior to or during the visit and should include both the site visit team captain and the team member. The Program Director will be responsible for assisting the team captain with arranging the conference call. At least one representative from the sponsor's administration is also required to be available during the on-site review.

RA SSR Review Tip

*Remember to focus on the highlighted items, Form X, and items that were not marked as met by the referee on the SV Report.
(you do not have to look at every Standard or piece of paper)*



You do not have to ask every question of the SV Interview Guide, but you do need to ask questions of the Faculty and Administration (even if you do not have any concerns). Give programs a chance to talk and brag about their program.



If you come across an issue you are not sure how to handle, remember to stick to problems/issues that can be cited with a Standard reference, and when in doubt call the Executive Director or the Referee.

AS A REMINDER...

- To maintain an Active Status - Site Visitors must participate in at least an average of one site visit per year every 3 years (i.e., a minimum of 3 SVs in a 3 year period).*
 - Send an updated CV to Bonnie if you have any changes in profession or credentials.*
 - Let Bonnie know if you are no longer interested in serving as a CoARC Site Visitor.*
